Training and Services Agreement

The owner of the above horse and Wright Way Stables agree to the following:

1. Owner agrees that Wright Way Stables will provide board and training services at the rate of \$_____ per month. Fees pertaining are those on the current fee schedule. Fees are due and payable on receipt of invoice, with services billed at the beginning of the month of service rendered. Any account with an overdue balance after 30 days will incur an interest charge of 1.5% per month of overdue balance.
2. Wright Way Stables agrees to advise owner, as soon as practically possible, of any illness or injury to the horse. Wright Way Stables is authorized to have their veterinarian, dentist, farrier, etc., to treat horse if needed, without consent of owner, with owner liable for the cost of said service.
3. It is agreed that Wright Way Stables, its owners, trainers, agents, apprentices, veterinarians, dentists and farriers shall not be held liable for injury, disability or death of any horse in its continuous care and control (on or off the premises) except for gross negligence or willful misconduct said by agents.
4. Owner is liable for any damage to persons or property caused by the owner's horse, and agrees to defend Wright Way Stables in any legal action relating to horses' actions.
5. In the event that the horse is sold while at Wright Way Stables, owner shall pay Wright Way Stables a 10 % commission on the sales price, regardless of how the purchaser was identified or the sale transpired. Commission is due in full upon receipt of down payment.
6. In the event that a client purchased a horse, using Wright Way Stables as agent, new owner shall pay Wright Way Stables a 10 % commission on the purchase price. Commission is due in full upon deposit of purchase price. If no purchase is made, Wright Way Stables may charge a day fee for time spent looking.
7. Any horse in training with Wright Way Stables and showing under the Wright Way Stables banner shall be transported by Wright Way Stables to the horse shows.
8. Any owner leaving Wright Way Stables will settle all indebtedness to Wright Way Stables, and their vendors, including but not limited to farrier, veterinarians, and transporters. **No horse will be allowed to leave before all accounts are paid in full. There are no exceptions to this policy.**
9. Owner agrees that Wright Way Stables has a right to lien horse for unpaid services, and has the right, without process of law, to retain horse until all bills are paid in full. In the event that Wright Way Stables exercises its right of lien for unpaid services, this agreement shall constitute a bill of sale that, together with an affidavit setting forth the facts of the default and Wright Way Stables compliance with the foreclosure procedures of the State of Maine, will authorize transfer application from any breed organization applicable to said horse.
